

FGM/C Safeguarding Pathway

For Social Workers, Frontline Service Providers & Mental Health Professionals

An adult or child discloses that they have undergone female genital mutilation/cutting (FGM/C)

Refer to the FGM/C Risk Assessment and Intervention Tool Communicate to your client your responsibilities to report abuse and confidentiality limits

Individual is under 18

Individual is over 18



- a) Follow your Duty to Report protocol on cases of child sexual abuse.
- b) Contact Child Protection Services. Check your province for the age at which Child Protection Services needs to be contacted. Child Protection Services will initiate a multi-agency safeguarding response.
- c) If FGM/C happened in Canada Child Protection Services must contact law enforcement. This is now a criminal investigation.
- d) Ensure a referral for a paediatric appointment and physical examination are made.

Is there an immediate threat or danger to the individual's physical/ mental health or life?



No

- a) Create a safety plan with the client
- b) Call law enforcement if necessary
- c) Determine if there is a connection to forced marriage.
- If Yes, refer to appropriate resources.

Do they have any female children or siblings at risk of FGM/C?





- a) Complete FGM/C Risk Assessment & Intervention Tool if possible **OR**
- b) Share information with multi-agency partners to initiate Duty to Report response.
- a) Provide or refer client to mental health support

- b) Encourage your client to connect with their doctor to obtain medical support
- c) Connect them to End FGM Canada Network for additional vetted FGM/C resources www.endfgm.ca



FOR ALL CLIENTS
